

Child Care News...

On October 4, 2010, NACCRRA (National Association for Child Care Resource & Referral Agencies) released its newest report, *The Impact of the Economy on Parents' Child Care Choices and Perspectives*, which found that quality and cost remain the most important factors for parents when choosing child care.

The report shows that despite modest improvements in the economy, many families are still struggling. Nearly 40 percent of parents say the current economy has affected their child care arrangements and they worry about not being able to meet their household expenses. Three-quarters of parents rate affordable child care as the most important (31 percent) or one of the most (45 percent) important factors in helping working families. Other key findings of the report:

- The majority of parents believe state laws and regulations ensure that child care settings are licensed and safe. Nearly 85 percent of parents believe that providers have undergone background checks; 73 percent believe providers are trained in child development; and 78 percent of parents believe child care is licensed.
- Parents' perceptions about laws, standards and oversight far exceed weak federal and state government policies. In reality, only 10 states require a comprehensive background check for child care providers; about half of states inspect child care settings only once a year or less and some inspect child care settings once every five or 10 years; and eight states grant family child care providers a license with no previous inspection or site visit.
- Despite the down economy, parents want quality child care. Nearly three-quarters of parents (73 percent) said that they support investing more government money in improving the quality of care, even if it means they would have to pay \$10 more in taxes per year.
